### **Timeframe**

Per s. 7 of the <u>Student Conduct Policy</u>, an appeal to the Non-Academic Appeals Committee must be filed no later than 4:00 p.m. on the tenth working day after the date of the Student Conduct decision being appealed. If the deadline date coincides with a day on which the University is closed, the deadline for filing the Notice of Appeal is 4:00 p.m. of the next regular business day. All necessary documentation must be submitted in this timeframe.

#### **Documentation**

The following documentation must be appended to this form:

- a. The decision that is being appealed;
- b. The form of remedy/outcome requested;
- c. The specific grounds on which the appeal is made. Please note that grounds for appeal to the Non-Academic Appeals Committee can only be made on the basis of a procedural irregularity, or on the basis of new evidence that was not considered at the time of the decision through no fault of the appellant; and
- d. A summary of the evidence in support of these grounds.
